JOB DESCRIPTION

Bingwi Neyaashi Anishinaabek (BNA) is looking to hire a Lands Assistant to work with both Chief and Council and the Director of Lands and Resources on the formulation of the BNA Land Code.

DUTIES AND RESPONSIBILITIES

- Work with the Director of Lands and Resources to prepare material for committee meetings;
- Organize committee meetings with committee members and BNA staff;
- Attend all committee meetings, take minutes, and ensure all concerns/comments of committee members are well documented; and,
- Work with the Director of Lands and Resources and outside consultants on any technical documents associated with the First Nations Land Management Act (FNLMA) and/or the Land Use Pilot project.

EDUCATION/PROFESSIONAL REQUIREMENTS

- Minimum Grade 12, or an equivalent combination of education and experience in a similar or related position with a proven demonstration of skills;
- Experience communicating verbally and in writing, and in public presentations;
- Organized and punctual;
- Must be/become familiar with the FNLMA and its processes/applications.
- Must be available to attend evening committee meetings, and to work after hours, if required;
- Ability to speak Ojibway is an asset;
- Must possess a current and valid Driver's License and dependable vehicle.

Bingwi Neyaashi Anishinaabek will look to its membership to fulfil this position; however, if a qualified candidate cannot be found within our community we will look to an Aboriginal person outside of our community and finally open to general public if a suitable Aboriginal person cannot be found.
