# A Message from Chief & Council

Greetings BNA Members,

As we embrace the arrival of a new year, Chief and Council would like to extend warm wishes for a happy, healthy, and prosperous New Year to each of you. With the start of 2025, we take this opportunity to reflect on recent events.



On October 21st, Chief and Council joined forces with Red Rock Indian Band, along with numerous Chiefs, Councillors and members from various First Nations in the region, in a peaceful protest. The protest was held in response to the discovery of 600-year-old ancestral remains during the construction of a visitor center in Nipigon by Parks Canada.

The construction activities led to the removal of approximately 60 unaccounted-for loads of dirt from the site, which are believed to contain some of the ancestral remains. These remains are a sacred connection to our heritage, history, and ancestors. The peaceful protest highlighted the urgency of finding and returning these remains to ensure they are treated with the respect and dignity.

Chief Council and stand firm in solidarity neighboring with our First Nations in advocating for accountability, transparency, and the preservation of our cultural heritage.

A community meeting was held on November 2nd, where BNA members had the opportunity to receive updates on critical legal matters from our legal counsel. Robert Botsford of Carrel and Partners and Lucas Jewitt of Edward Bell Jewitt LLP provided detailed updates on the ongoing BNA Title Case and the Robinson Superior Annuity Case.

These cases are of great importance to BNA, as they address key aspects of our rights, lands, and entitlements. Chief and Council are committed to keeping members informed as these cases progress. Your support and engagement are essential as we navigate these significant legal matters.



November 4th Greg Rickford, On Minister of Indigenous Affairs Ontario attended the Court Street satellite office to congratulate BNA on securing funding from the Indigenous Economic Development fund and to advise BNA future funding opportunities. of This funding has allowed BNA to hire Katia Borjas, Economic Development Coordinator standing next to Minister Rickford in the picture below. This funding is a step forward in creating sustainable opportunities and prosperity for our community.



The Annual Community Christmas Party was held on December 7, 2024, and was very well attended. Santa appeared with gifts for the children, and everyone enjoyed a hot festive meal. Out of town members were gifted with a monetary deposit to their accounts allowing them to purchase gifts for their children and purchase items for a festive meal. Members who have not supplied BNA with their banking information would have been mailed a cheque once the striking mail employees returned to work.

4 newly built homes and 2 four plexes are now complete and ready occupancy and funding has been secured for the construction of 3 more homes supporting the goal of bringing BNA members back to their homeland.

The current Chief and Council's 4 year term is nearing its end. We are excited about the upcoming election that will take place on Saturday, May 24, 2025, using our newly ratified Election Law that allows for a fair and transparent process. We encourage every BNA member that is 18 years of age and older to vote. Voting packages will be sent out to members 18 years of age and older, provided their address is up to date with BNA.

As we move forward into this new year, Chief and Council remain committed to advocating for our rights and ensuring the continued growth and well-being of BNA. Your support and participation in these efforts are invaluable, and we encourage all members to stay informed and engaged in the issues that impact our community.

# Economic Development Lepdates

### On-Reserve Pit

BNA is currently working with the Transportation Ministry of and Asiniikaa Mining to open its onaggregate pit. The reserve pit location at the back end of 'Lot C' of the BNA Industrial Park, and a road has already been build to access The stockpile from the the site. pit will initially provide material to the province for their upcoming highway jobs. However, BNA plans to crush additional material for its on-reserve development projects, as well as sell to third parties for additional revenues. The site has been cleared and grubbed. Fortunately, we had a long fall season, which allowed work to continue through November and December. The on-reserve blasting and crushing will commence in the Spring of 2025.

Papasay's currently permitted pit located 3 kilometers from the Copper Thunderbird Road entrance - is nearly depleted, and we will be working on its rehabilitation as required by the Province.





New Greenstone Transmission Line

In the fall of 2024, BNA formed an alliance with its neighbouring First Nations along the Transmission route - including Red Rock Indian Band, BZA, AZA, Ginoogaming, and Aroland - to bring more reliable transmission to the region, with increased capacity for regional developments. Our collective goal is to vastly improve the current electricity system in the region by bringing in a new 230 kV transmission line. The current A4L line has issues with both reliability and capacity. The current line is unreliable, causing both brownouts and blackouts for the communities along its route, including BNA. Also, it lacks capacity and is unable to handle larger development projects, including community developments or critical mineral mining operations. The new line will follow the existing corridor on the east side of Lake Nipigon along Highway 11, which would minimize any environmental impacts. This line is critical for the region, as it will bring benefits to two newly building First Nations, BNA and AZA. Furthermore, as mining becomes prominent in the region, the need for a line with greater capacity will be required. With this project, the underserved community of Greenstone will have greater opportunities to grow and prosper.

The 6 First Nations met with Ontario Premier Ford, Minister Douq of Indigenous Affairs Greq Rickford, and Energy Minister Stephen Lecce in Toronto on November 6, 2024, to advocate for this new transmission line. The Province supports this project, but along with the political push, we need to participate in the IESO's energy planning process currently underway. Regardless, BNA will continue to work cooperatively with our neighbouring communities to make this project a reality.



### Wind

With the new transmission line project starting to get some momentum, BNA along with our neighbouring communities of BZA, AZA, and Red Rock Indian Band, are continuing their work regarding seeking out wind opportunities on the southeast side of Lake Nipigon. BNA and its partnering communities have met with Innergex, a Quebec-based renewable energy company, to discuss setting up met mast towers to test wind speed in the area.

when the Green Energy Act was repealed. As this legislation included a "feedin-tariff" (FIT) program, once this was lost the former project lost its economic viability. Also, the previous wind project had no high-capacity transmission line to connect to. With the construction of the East-West Tie line, and the new Greenstone Line soon to come to fruition, this issue will now be solved for the current Wind project.


The next step for this project will be for Innergex to set-up mobile wind readers to test the wind speeds in the area, which will provide necessary data to both Innergex and the communities for the IESO's current planning process. We also need to form a legally binding partnership agreement between Innergex and the 4 First Nation communities. There will be lots of work in 2025 on this Project.

### Papasay Sawmill Expansion

The Papasay Sawmill Expansion project has been in progress for several years. While production has dramatically increased with the new equipment that has been added, the need for a new building has slowed our acquisition of our value-added line. BNA has been reluctant to order the new value-added line due to the limited space in the current building.

With the upcoming Federal election and ongoing discussions with our funders (Natural Resources Canada and FedNor), BNA needs to proceed with the equipment order and expenditure of the current funding. Therefore, we will be purchasing several pieces of new equipment, including a new dust collection system, additional attachments for our loader, and the automation of our current planer moulder unit. The latter will allow

Papasay to ensure it will have all the all of these processes. BNA can no structural lumber needed for the next round of homes in the community. All remaining funding will go toward the purchase of the Carbotech value-added line, which we will be proceeding with once we receive its advance from the funders. BNA will continue to work with funders to ensure that a new building is in place before the new Carbotech line is delivered to the Industrial Park.



### New BNA Mining Coordinator

As mining and exploration continues to grow in the east of Lake Nipigon region, the workload for BNA has increased as a result. Along with this increase in activity, BNA is faced with issues concerning mining claims, permits and the development of exploration agreements, negotiations Impact Benefit Agreements with of mining entities, and working with neighbouring communities our on

longer depend solely on the Nokiiwin funded Mineral Development Advisor (MDA) position. The MDA has multiple responsibilities spread over multiple communities, which limits what BNA can accomplish on the mining front.

To assist with the growing workload and the various mining projects that our community is currently working on, BNA proceeded with the hiring of our own internal Mining Coordinator. We would like to welcome Kimberly Rozon as our new Mining Coordinator, starting at the end of January. Kim was formerly Nokiiwin's MDA, but will now assist BNA with its current workload and help us get more organized on the mining front. Kim is a member of the Red Rock Indian Band, and has a wealth of experience on mining-related matters. Please welcome Kim to her new role as the Mining Coordinator!





### Title Case and Annuities

BNA has continued its Title Claim and Annuities negotiations with both Canada and Ontario, as both files are very active.

held a community meeting in BNA November to discuss both the Title Claim and Annuities with our members. In this meeting, our legal team, land specialist, and economist presented details of both processes to the community. Following this community meeting, the Chief, key staff and legal team also presented to the Quebec members in French on November 16th. BNA has established a Communications Committee that includes representatives from different BNA families, as well as the Chief and legal team. This Committee is in place to provide recommendations to the Chief and legal team, as well as communicate with the members' respective families regarding any updates.

January was a busy month for the Annuities file, as Chief Gladu is one of the main negotiating Chiefs on the file. As members know, we recieved an offer from Canada and the Province at the end of January.

While both processes are very confidential, BNA will do its best to provide as much information as possible to its members as it becomes available.



### BNA On-Reserve High-Speed Internet


Internet connectivity is an on-going issue in Northwestern Ontario. As everyone knows, BNA has little to no data service on reserve. The Province has promised to connect every Ontarian to high-speed internet by the end of 2025. Nonetheless, the divide is still great, and many communities in Northern Ontario do not have the proper infrastructure in place for high-speed Internet.

BNA has been meeting with Infrastructure Ontario to find a communications solution to this problem. The Province has proposed a satellite solution for on-reserve high-speed Internet. We will be meeting with representatives from the Province to discuss the details of the new program, and how we can participate. We are eager to find a long-term solution to our on-reserve communications issues.

As we learn more about this new program, we will inform BNA members.

On-Reserve Rental Spaces for BNA Entrepreneurs

BNA put out a notice to members this past fall regarding spaces on-reserve for member-owned businesses to have an on-reserve location and address. BNA wants to expand its internal economy, and to do so, the community wants to build office and rental spaces to house businesses for community entrepreneurs.

The response we received to this notice indicated that there was more demand than available spaces. Therefore, BNA will be renovating its bunks in order to provide additional rental spaces to member-w

We will provide more information as it becomes available.

### MTO Highway Projects

BNA is working hard to improve its relationship with MTO so that it can maximize its opportunities for the highway work happening in the region. As previously reported, in the spirit of regional collaboration and partnership, BNA and BZA First "2-Nations Nations have formed Construction LP", which can partner with highway contractors to bid on projects occurring near their communal traditional territory. Along with the formation of the partnership, some additional benefits include selling aggregates from the new BNA pit, rental of Papasay heavy equipment, the rental of spaces for contractors or project managers, and potential laydown areas for rent in the Industrial Park. Through our new partnership, we have received an opportunity for a singlesource culvert job, and will be looking at building internal capacity to take on larger projects along the Hwy.





### Infrastructure



### Waste Transfer Station

Bingwi Neyaashi Anishinaabek (BNA), in collaboration with TBT Engineering, has initiated the design stage for state-of-the-art Waste Transfer а Station, marking a significant step in enhancing the community's waste management infrastructure. With 66% of the design completed and currently under review, this critical phase will quide the project into construction, which is anticipated to begin in the summer of 2025. The design is expected to be finalized in the first quarter of 2025, paving the way for a modern and efficient waste management solution. Once completed, the Waste Transfer Station will support the community's growth by providing sustainable and effective waste disposal services, reinforcing BNA's commitment to environmental stewardship infrastructure and development.



### Kubota Equipment Purchase

Infrastructure The Department of Bingwi Neyaashi Anishinaabek (BNA) has invested in a new Kubota L6060 Tractor to enhance the efficiency and effectiveness of the Public Works This essential Department. piece of equipment will play a key role in daily operations, including snow removal, road maintenance, and other vital public works functions.

Additionally, the tractor will support housing-related activities, such as property maintenance and infrastructure repairs, ensuring that community needs are met as BNA continues to grow. This purchase represents a significant step toward equipping the Public Works Department with the tools necessary to maintain and improve community infrastructure, with plans to acquire additional equipment to meet the increasing demands of a growing population.

### Lot Development

The lot development project for Bingwi Neyaashi Anishinaabek (BNA) is progressing steadily, with the final stages of completion anticipated by 2025. To date, significant milestones have been achieved, including the development of 19 residential lots, community ditching improvements, and partial driveway access to each property.

The next critical step involves the construction of Cedar Bay Road, which will provide essential access to Lots 1-6, designated for the Build Your Own Home program. This final phase will not only enhance connectivity within the community but also support future residential growth, ensuring that BNA is well-positioned to meet the needs of its members and foster sustainable development.



### Community Street Lighting

Bingwi Neyaashi Anishinaabek (BNA), in partnership with Nokiiwin Tribal Council, is actively preparing а Minor Capital Application (MCA) for submission to Indigenous Services Canada to address critical infrastructure needs in the community. Recognizing the importance enhancing safety for residents of and visitors, BNA is focusing on the installation of street lighting to improve visibility and security along community roadways. This initiative a direct response to concerns is about safe travel in and out of the community, as well as overall public safety. The completed application is scheduled for submission in the second quarter of 2025, reflecting BNA's commitment to fostering a safe and well-lit environment as the community continues to grow.







### Lands & Environmental Coordinator

### Freshwater monitoring Program

In collaboration with the Nokiiwin Tribal Council, BNA started an environmental monitoring program focused on assessing the health of Farlinger Creek (located by the greenhouse) chemically and biologically. Regular monitoring is critical for establishing a baseline throughout the seasonal fluctuations and if changes are occurring to the wide range of metrics. Changes to the creek can be caused directly by disturbances such as infrastructure, forestry, and mining or in line with broader pattern changes due to climate change. BNA is seeking funding to continue monitoring the creek for heavy metals, other contaminants, and biological sampling. While the monitoring program is still being established based on best research practices, the chemical sampling is planned to be done monthly from April to October, and the benthic sampling will be done yearly in the fall.



In 2024, the Ontario Benthos Biomonitoring Network certified several participants from this program. Having trained individuals also allows BNA to implement its program without the need for costly consultants both in the field and in the lab.



Field: Over the course of nine sessions, a team of environmental guardians and staff from Nokiiwin communities and Up North on Climate collected samples of insect larvae and other invertebrates using the kick and sweep method. They also recorded metrics, including water temperature, depth, and acidity.





Lab- Once the three collections of a minimum of 100 samples were sorted from the sand and plant matter in the water, the samples were identified into 22 categories, including snails, dragonflies, mosquitoes, and crayfish. Each category has a score assigned to it, which is then used to calculate a weighted average. With this score, out of 10, changes in the health of the benthic community can be determined and charted over time.

For 2024, the creek's average score was 6.4 across the 3 samples, placing Speckled Creek in the "good" range based on the Hilsenhoff biotic index (fig 1)

### NEW Compost program

As the reserve population increases, so does the need for a customized waste management system to keep the community clean. A more mindful approach to organic waste can manage a significant amount of household on-reserve waste. The community composting program is expected to reduce household waste by about 40%. This will not only reduce the amount of sticky garbage bags being brought to the curb but also increase the nutrients added to the soil for the gardening projects on the land. BNA is also expecting to see a cost saving as it will reduce the overall weight in garbage collection reducing tipping fees.

Starting in the Spring of 2025, BNA will launch a pilot program in collaboration with the Lands Advisory Board Resource Centre to determine how to deal with organic waste effectively. The goal is for this program to be a multi-year initiative to explore organic waste management options. The first step of this program is a feasibility study to determine what composting methods will best suit the on-reserve community. A small-scale program will be started based on this study and community input. With results collected from test households, the program will be refined and expanded to more households. While initially, this program will only be for on-reserve members, there is the potential for it to grow to off-reserve members.

Some of the options being explored are as follows.

- Bokashi
- Electric counter top composters (lomi/ food saver)
- Outdoor Barrel units
- Vermicomposting (worms)

### District Heating Project

BNA is currently finalizing funding for the construction of the district biomass heating facility. This project overall has an estimated cost of \$12 million. We have started the retrofitting process for 14 homes.

The project consists of using one small and one big boiler to provide heat for a large portion of the BNA community. The distribution lines will be buried underground and can last for approximately 30 years.

The residual wood that comes from Papasay will be chipped and utilized as the source of energy to heat the homes. This project will create job revenue for BNA in the upcoming years when construction is completed. BNA is one of the few First Nation communities within Northwestern Ontario to have a district heating system. The district biomass heating system is a clean and reliable way to heat homes.

### Drone project

successful in BNA was receiving funding from CIRNAC to purchase our very own drone. This funding is to support continued climate change adaptation and clean energy work. Most importantly, the program is designed to increase the resilience of Indigenous and Northern communities by supporting the integration of climate information in decisionmaking. The drone has been purchased and collection of environmental, climate and other data will happen in the summer of 2025.




